



#### 7. Old Business

The following items were identified as action items following last year's AGM and dealt with by the Board of Directors during the past year.

- a) Request to revisit for next year's AGM the policy on providing a prorated membership fee for members joining a club after April 1<sup>st</sup>.
  - Action: The Board revisited this decision following the AGM and agreed to return to the practice of offering half-year fees as of May 1<sup>st</sup> of each year.
- b) It was suggested that the association look at conducting annual reviews rather than audits as these are less expensive. The president indicated that this item had been previously considered and rejected due to the Societies Act requirements. The Executive Committee will review the suggestion and report back at next year's meeting.
  - Action:Our funding partners require us to submit Audited Statements are part of our reporting. Reviews are there not possible.
- c) The new registration system was reviewed and it was decided that the executive would work with the developers to ensure that the system is as complete as possible prior to rolling it out nationally. If it is felt that the system is not ready for roll out in September then the same method as last year will be used for registration.
  - Action:We continue to work closely with Judo Canada on their new system while investigating possible solutions for BC. We have an ad-hoc committee (Sean Hall Chair, Beth Roots, Lorna Nakajima and Tokue Suda) looking a few options. The Board will continue to working towards a solution that meets the clubs, Judo BC and Judo Canada needs. We will not launch the new system until we believe it can be successfully implemented.
- d) Using the updated NCCP database, review the ratio of coaches to athletes within each club and zone and identify gaps which must be addressed by 2014-15.
  - Action: This action will be undertaken once the CAC staff has completed the transfer of data from the old system to the new database "The Locker".
- e) Using the updated NCCP database, articulate and provide each coach, who has already completed some form of NCCP work, the path they must follow to achieve full certification.
  - Action: This action will be undertaken once the CAC staff has completed the transfer of data from the old system to the new database "The Locker".
- f) Identify the process to secure the support/approval from Judo Canada to grant professional development points (for coaching certification) for activities/clinics Judo BC will be hosting.

Ensure the process for securing approval is clearly communicated to clubs who may wish to host such events.

Action: Dialogue is ongoing with on this topic. We are aiming to have a full update for you at the start of the fall season.

g) Secure confirmation from Judo Canada and the Coaches Associations of Canada on how points get submitted for coaches. These include but are not limited to professional development activities we may be hosting, to actively coaching. The goal is to develop a streamlined approach which could be managed by the office.

Action: Dialogue is ongoing with on this topic. We are aiming to have a full update for you at the start of the fall season.

h) Clearly articulate the process for securing coaching certification equivalency for the following: (a) Foreign certification; (b) University courses or degrees; and (c) Shodan status.

Action: Dialogue is ongoing with on this topic. We are aiming to have a full update for you at the start of the fall season.

i) Give feedback to Judo Canada on the participation of young and white belt Judoka in tournaments.

Action: President has shared our views with Judo Canada.

j) Review Nidan requirement to open a new club.

Action: The Board has chosen to retain the current standard of Shodan.

k) Continue to identify simple and effective ways to track our membership and reach (i.e.: school presentations, demos, self-defence clinics).

Action: We currently have a one page document which can be filled out and fax or scanned/email back to Judo BC. We hope to move this process online when we implement our new registration system.

 Work with Judo Canada to building a promotion program that will target our needs and capacities.

Action: Board representatives at the Judo Canada level continue to recommend action in the area of promotion. Judo BC may need to look at developing its own tools. This will be a function of the Membership Committee.

m) Ensure the new membership committee has the resources to actively assist clubs in reaching their full capacity and to start new clubs.

Action: The Board will ensure resources are made available to the committee once they identify the activities they wish to undertake to help our clubs reach their full capacity and to start new clubs.

n) Policies must include a reference that clubs have the autonomy to manage their day to day operations but must, as members of Judo BC, ensure they adhere to constitution, bylaws and policies for association.

Action: This item was addressed has part of last year's bylaw discussions.

## FINANCIAL REPORT FOR THE AGM OF 22 June, 2013

#### Notes to the Report:

- At the time of the report Judo Canada had not decided on the new age categories and although there is a
  budgeted increase in Judo Canada fees for various age groups, the exact logistic (age divisions) of the fees
  are not yet determined. The Judo Canada fee schedule is being discussed and voted on at the Judo Canada
  AGM the weekend of June 7<sup>th</sup> and 8<sup>th</sup> and the results of those decisions will be announced subsequent to
  being informed of the outcome.
- The audited financial statements have not been received from the auditors at the date of this report due to Judo BC hosting Nationals and the fact that we have a 60% employee shared with Karate BC. The audited financial statements will be sent to the membership as soon as they are ready. A current budget, containing the un-audited financial position of Judo BC is included in the report.
- The 2012-13 fiscal year saw some changes in the financial arena. Judo BC is getting its' funding from viaSport, the newly created arm of the provincial government. Through this venue, Judo BC is expecting similar funding support for the 2013-2014 fiscal year as we realized for the past fiscal year.

#### 2012-2013 fiscal year highlights:

- Due to sharing a staff position (replacing Diane St. Denis with Katie Thomson) with Karate BC, Judo BC realized a decreasing in the budget for staff expenses. That being said, the monies saved in the 2012-2013 fiscal year will be offset with increased staffing expenses to accommodate a full time staff position and an additional Sport Director position. The SD position has not yet been filled and the Judo BC Executive are still actively seeking applicable candidates.
- Membership revenue is budgeted to be up slightly, year over, based on current membership trends.
- The referee committee, grading committee and coaching committees run very close to revenue neutral, with the grading committee contributing slightly higher revenue than expenses last year.
- Athlete development (support) budget is significantly reduced for the 2013-2014 fiscal year due to Judo BC hosting Nationals. Some of the cost savings of the Nationals being in BC is offset with higher hosting cost.



# 2012 / 2013 - President's report


There have been many changes in Judo BC this year. One of the biggest changes was the leaving of Diane St-Denis from our organization. In her time with Judo BC she helped us grow and develop as an organization and will be sorely missed. However with every ending there is a new beginning, Judo BC and Karate BC worked together to hire a joint staff member and Katie Thomson has been on board for almost a year now.

Understanding that one part time staff member is not enough for our organization we also endeavored to hire a new technical staff member as well. The hiring process for the Sport Development Director was not as successful as the one for program coordinator as we had limited candidates apply and our chosen candidate declined our offer after several weeks of negotiation. Regardless we are reposting the position and hope to get someone in place by next Judo season.

Another exciting event and also a challenge is the Canadian Judo Championships being held at the Richmond Olympic Oval this July. It is a great opportunity to showcase Judo in our province but also a huge undertaking, I am very lucky to have an experienced and dedicated organizing committee that is working very hard to put on a great event for everyone involved.

Our relationship with viaSport, our main funding partner, is as strong as ever and we have worked with them to develop additional programs and funding. Prince George Judo club hosted their Success through Judo program, based on the Judo Canada Eclipse program. This program, which helps at risk youth develop through Judo, was partially funded by a BC Sports Participation Program grant as well as Judo Canada grants and funding from Judo BC. We have funds left to run additional programs and anyone interested should contact me or Katie for more information. Also on the funding front we applied for the first time for the Integrated Performance System. This program has been developed to help support provincial high performance programs by funding coach's wages. We were approved for matching grants to help with two regional coaches and will use these funds to help hire our sport development director and keep a regional coaching presence in the North.





As most of you know Prince George will also be hosting the 2015 Canada Winter Games and we have been working with the organizing committee to ensure the Judo tournament will be well prepared to put on the event. Aline Strasdin has been named the Sport Leader for Judo at the games and is well entrenched in the CWG system. Our first test event identified some improvements to be made and the games were generous enough to provide a funding for two roll out mat areas for the Prince George Judo club, to be used at the Games. Aline has very kindly agreed to make these mats available to other clubs in the province. I am very excited at the opportunities this opens for our clubs and look forward to discussing this with everyone.

As always I would like to thank the many volunteers, committees, executive and staff for their tireless work throughout the year and I look forward to carrying on with the programs we have been working on.

Judo Canada is the national sport governing body for the sport of judo in Canada and has overall authority to provide leadership in promotion and development as well as to govern all aspects of Judo in Canada and to select and prepare Canadian teams for international competition. Judo Canada is a not-for-profit charitable organization operating under an elected board of directors.

#### Our Vision:

- Canadian judoka are consistently placing in the top 8 at World and Olympic and Paralympic level competition.
- Regulations and standards for all aspects of judo are applied consistently for all judoka across Canada.
- Judo Canada has a consistent presence at the Continental and International levels.
- Judo Canada's membership doubles by year 2016.
- Judo Canada is recognized as one of the World leaders in the popularization of judo programs aimed at disadvantaged populations.
- Judo Canada assists in successful introduction of judo in various education institutions/organizations across the country.

#### **High Performance Director**

On October 31, 2012, Judo Canada had approximately 12 applicants from a wide range of fields and with impressive qualifications. Interviews were conducted with Graham Burton (OTP), Daniel DeAngelis (BoD), Louis Jani (HP Committee) and Benoit Girardin (LBB Consultants). At the December 14<sup>th</sup> to 16<sup>th</sup> Board of Directors Meeting, a motion was approved on the appointment of Danek Nowosielski. Mr. Nowosielski accepted the job and signed the contract on February 1, 2013.

#### **Executive Director**

On September 16<sup>th</sup>, 2013, Judo Canada Board of Directors appointed a hiring committee for the position of Executive Director. Mike Tamura (BoD), Shu-Tai Cheng (BoD), Andrzej Sadej (Staff) and François Allaire (Sport Canada) were approved as the hiring committee. Applications were received from 23 individuals The committee short listed the applicants, and 4 interviews were held on January 17<sup>th</sup>, 2013. On February 5<sup>th</sup>, 2013 the Board approved of Adrien Landry for the position of Executive Director. The contract was finalized and the official start date was February 18<sup>th</sup>, 2013.

#### **Judo Canada Appoints Vice President**

After the election on September 16<sup>th</sup>, 2013, the Board of Directors were asked to submit names for potential candidates for the position of Vice President. Email exchanges and discussion followed and various names were forwarded across Canada. At the December 14<sup>th</sup>-16<sup>th</sup> Board of Directors Meeting, Mr. Roger DesChamps was nominated for and accepted the Vice President Position. The term will be until the June 2014, elections. Mr. DesChamps is the treasurer of Judo Quebec, and a National "A" Referee. With the nomination of Mr. Des Champs to the new position, he vacated the Regional Director (Quebec and Nunavut) position which was subsequently filled by Mr. Alex Ciupe.

#### Office Staff

The President reviewed the structure and the workload on the current staffing model of the office. In review of the outcomes of the office staff, Judo Canada is very fortunate. Indicators have shown that our organization maximizes the output on workload and expectations of achieving consumer satisfaction. Potentially the office could use one additional staff member with specific duties and assignment of obtainable goals that would benefit the consumer. Overall Judo Canada should appreciate the dedication and endless devotion to making sure all members are satisfied with our organization.

#### Judo Canada AGM 2013 - International

#### IJF

March 3<sup>rd</sup> -4<sup>th</sup>, 2013 Board of Directors Meeting reviewed the new rules implemented by the IJF. Judo Canada's Tournament Committee and Referee Committee are looking at how this will affect the Canadian National Championships. Issues arising are the weighins the night before, more shidos and the one referee system. Tamura (President), Grifo (IJF), DeAngelis (Secretary General) and Ciupe (IJF) discussed business with the President of the IJF at the Pan American Congress. Tamura and DeAngelis also met again with the IJF President and the Secretary General of the IJF in Tokyo. The relationship with the IJF is as strong as ever and we have solidified a great connection with the IJF, which is good for our athletes, referees, and Judo Canada.

#### PJC

The President and the Secretary General attended the Pan American Congress on January 12<sup>th</sup>, 2013. Also in attendance were Alex Ciupe and Vincent Grifo, both representing the IJF. We spend a few hours with the IJF President and had a great time discussing the state of Judo in the World. We also had an hour with the PJC President and discussed the issues within our Union. De Angelis raised issues of communication and the website needed for the PJC. Tamura requested more involvement of Judo Canada with the PJC. We also discussed positions and the representation of Canada at the table. The PJC then selected V. Grifo as a member of the PJC referee committee as well as the Vice President Position of the North Central Sub Committee. Tamura and Grifo spent many hours discussing the positions and the concerns that Judo Canada have and the need for communication and positive relationship between the President and the PJC. Mr. Grifo definitely agreed and was willing to do whatever is needed for Judo Canada.

#### **Commonwealth Games**

At the March 2-3<sup>rd</sup>, 2013 Board of Directors Meeting, it was confirmed that the Commonwealth Games will have Judo as a sport being held in Glasgow, Scotland, July 23<sup>rd</sup> to August 4<sup>th</sup>, 2014.

#### Pan-Am Games 2015

Judo Canada is trying to secure financial support for hosting Pan Am Championships 2015 as a test event for the Pan Am Games 2015. We will move the event if we get no funding from Toronto to another major city in Canada. Decisions will be made in early June.

#### Judo Canada AGM 2013

#### Judo Canada Database and event management software

December 15<sup>th</sup> – the Board of Directors discussed the issues surrounding Pragma and the database. The Board agreed on researching a possibility of using an open source solution with modifications. Some logistical problems should be reviewed such as standardization of membership categories across Canada. The next year the Board will review the database and Pragma systems.

#### LTAD Model

March 3<sup>rd</sup> – Discussion on the LTAD and the need to implement a clear Implementation Plan Progress Report. This is due to issues on the Sport Funding and Accountability Framework (SFAF) and what Sports Canada requests. Sport Canada would like a point-to-point implementation plan for LTAD, as a separate document.

#### **Domestic Sport Competitions System**

The Tournament Commission has been busy working on setting up Quebec Open and Ontario Open back-to-back with a Judo Canada Training Camp in between. This would also be done out west with Pacific International and Edmonton International. We would then integrate an Open Judo Championship and an Elite National Championship that would be showcasing our top 8-10 Athletes. Implementation is in the works and the logistics are currently being reviewed.

#### **Board of Director Meetings**

The current Board of Directors has been working on changing the governance culture of the organization. Over the two meetings held in December 2012 and in March 2013 the Board catalogued the strengths and weaknesses of the Board. We agreed and are working on changes to how we do business and the model we are trying to develop within the organization, which we agreed would take time. The Legal Committee is working on changes to Judo Canada's Bylaw which has been forced on us by the change to the federal Not-for-profit Corporations Act. The delivery of services to our consumers has now been the focal point for the Board of the Directors as we move forward, as this has been the discussion at both Board of Directors Meetings held December and March. The Board agrees that Development and High Performance must go hand-in-hand to be recognized by Sport Canada, Own the Podium, and Provincial and Territorial Associations. Focusing on what we need to do as an organization will be done under the Development Director and the High Performance Director. The Executive Director will manage both areas under the Judo Canada organization. The President and the Board of Directors will continue to consult and add input into the new direction the ship is sailing,

overseeing the Executive Director. Finally, the Board of Directors will gather information from the PSO across Canada to assist in the areas for growth.

#### Judo Canada AGM 2013- Committees

#### **Judo Canada Committees**

On December 14-16<sup>th</sup>, 2013 the Board of Directors agreed to assign a committee to each Director to review the 1) Terms of Reference and 2) Review the Budget. This was to bring consistency with Judo Canada's Strategic Plan. Some were already to be approved while others needed to be worked on. The Board of Directors also approved the Chairperson for each committee. Kodokan Committee was an issue because the Kodokan syllabus was removed from their website. A Succession Planning Committee was also discussed and tabled for now – this committee was one requested by the SFAF.

#### **Kata Committee**

On December 15<sup>th</sup>, 2013 at the Judo Canada Board of Directors Meeting, the motion was approved to split the Grading Committee and the Kata Committee into two separate groups. Kata has grown within the members of Judo Canada and it is time to set standards for competitions and selections for World Championships. Jim Kojima will remain at the helm of the Grading Committee while Hiroshi Nakamura will chair the new Kata Committee.

#### **Kodokan Committee**

On March 2<sup>nd</sup>-3<sup>rd</sup>, 2013, Board of Directors Meeting, the motion was made to separate Kodokan and Kata Committee. There are some issues of having no syllabus to follow or have a clear black and white system for Kodokan Dan Grading. Mr. Nakamura has the best knowledge and connections with the Kodokan since his peers are at the highest levels of All Japan and Kodokan Institute. Judo Canada should only be a facilitator of the Kodokan Dan Grading Approval since there is no way to define eligibility for acceptance and a non-acceptance for recognition of Dan Grade at the Kodokan.

#### **Tournament Committee**

The committee has worked on the Canadian Circuit, which would incorporate: Quebec Open, Ontario Open, Pacific International, and Edmonton International. Secondary Tournaments would be included but not closed to others, Saskatchewan Open, Atlantic Championships. The Tournament Committee is trying to get the Nationals and the above-mentioned tournaments to a level that is the highest standard possible for growth and development.

# Sport Funding and Accountability Framework (SFAF V Summer) (excerpts from Sport Canada)

Judo Canada Assessment 2004-2012

#### INTRODUCTION

The Sport Funding and Accountability Framework (SFAF) is a program assessment tool designed by Sport Canada to develop the Canadian sport system and to manage contribution programs to national sport organizations (NSOs) for both able-bodied athletes and athletes with a disability (AWAD). The SFAF provides Sport Canada and the Canadian sport community with an objective and transparent means of aligning federal funding support to NSOs with the goals and priorities of the *Canadian Sport Policy*. The framework is used to identify eligible NSOs, assess their governance and management, programs and services, engagement and communication to determine whether they qualify to apply for funding support; determine the reference level and area(s) of funding, and monitor accountability against accountability performance measures. The framework spans multi-year cycles. For summer sport NSO the cycles are: 1996–2000 (SFAF I), 2001–2004 (SFAF II), 2005–2008 (SFAF III), 2009–2012 (SFAF IV) and the SFAF V will for the 2013–2017 time period.

In the fall of 2011, the Canadian sport governing bodies for summer sport were invited to complete the SFAF V eligibility questionnaire. A total of 38 NSOs successfully met eligibility criteria and continued to the assessment stage. NSOs that apply for and meet eligibility criteria post-2011 will be assessed using the same assessment process, with slight modifications to account for their more recent data.

#### **ASSESSMENT**

The purpose of the assessment is to provide Sport Canada with an objective, fair and equitable means of determining the amount of funding for which organizations can apply, according to stated priorities. The assessment uses both objective and qualitative elements, based on a wide range of factual data, which have been designed to discriminate between sports, as well as ensure consistency and fairness.

The quantitative data includes information from official documentary sources such as Senior World Championship and Olympic/Paralympic Games results and coaching certification statistics obtained from the Coaching Association of Canada's database (locker). The international results cover a 9-year time frame (2004–2012). Most of the

quantitative data is collected and maintained in Sport Canada's S.T.A.T.S. Database. The qualitative assessment data is collected through information provided by the NSO (questionnaires, job descriptions, strategic and operational plans), and information provided by the Coaching Association of Canada (NCCP transition), and relates to the reference year 2010–2011.

Eligible NSOs were assessed using this rating guide. NSOs that met all eligibility elements in governance and management, programs and services, including B1-5 were assessed in all areas of this rating guide. NSOs that did not meet programs and services element B5 were not assessed on their Olympic/Paralympic/Senior World Championship results or International depth of field.

#### **ACKNOWLEDGMENT**

This assessment represents a very comprehensive, up to date and objective report on the status of organized sport in Canada. This information, combined with that collected in previous cycles, will provide data for comparative analysis of sports' progress and for the tracking of future trends. This wealth of information would not have been possible without the willing assistance of Canada's summer NSOs whose cooperation is most gratefully acknowledged.

#### ASSESSMENT HIGHLIGHTS

The purpose of the Assessment Report is to provide each NSO with a detailed summary of its SFAF V Assessment Results. The data collected are presented in a standardized form and includes, as appropriate, both raw data and assessment data. This approach provides the NSO with both the details of its assessment results and an up to date comprehensive profile of its sport. We believe this information provides important factual context for understanding sport development and high performance sport issues, both in terms of how sports have evolved in recent years and in terms of emerging trends. Among the highlights of this assessment:

- 40 mainstream summer NSOs, and 3 NSOs for athletes with a disability have been assessed
- The 43 NSOs represent 3,45M participants including over 178,000 registered coaches and 88,000 officials. Overall, this represents a 3% decrease from the previous SFAF.
- On average, 39% of all participants were female.
- Over 190,000 coaches have completed a NCCP certification level over the last 8 years, including 88,700 coaches who have been trained or certified under the New NCCP.
- In terms of mainstream international results, over 300 World Championships and 3 summer Olympic Games were assessed across 39 sports between 2004 and 2012. This represents 2,535 medal events and participation of approximately 2,756 Canadian athletes.

- In terms of international results for athletes with a disability, over 64 World Championships and 3 summer Paralympic Games were assessed across 19 sports between 2004 and 2012. This represents 2,390 medal events and participation of approximately 596 Canadian athletes.
- Canadians hold 184 international positions (regional or international executive or committee), and have had 418 major officiating assignments at Olympics, Paralympics or Senior World Championships in the last quadrennial.

#### **IMPACTS ON JUDO CANADA**

This recent assessment compared Judo Canada against all other funded summer sports in Canada by reviewing the past few Olympic cycles of activities. The immediate result has been a reduction to Judo Canada's core funding by almost \$90,000 annually. Of the 38 ranked summer sports, Judo Canada finds itself in 26<sup>th</sup> place.

There are a number of avenues to improve, all of which are highlighted in the final assessment report. Most improvements are to be focused in governance and high performance. The HP strategic plan is the tool that will guide the organization in the area of HP improvements. The Board of Directors is working on tools to assist with improvements in governance.

# COACH DEVELOPMENT COMMITTEE REPORT FOR THE AGM OF 22 June, 2013

#### **Professional Development Points Update:**

- PD points accumulation and recording will commence in January 2014.
- Judo BC needs to identify non-NCCP activities that we would like to have recognized for PD points (PD courses). These will then need to be entered into the LOCKER as approved activities, once approved by Judo Canada and the CAC. The Coach Development Chair (or their designate) will then update the activity of each coach after they have completed the activity. If you have any suggestions, please send them to <a href="mailto:nccp@judobc.ca">nccp@judobc.ca</a> to have those ideas brought forward to Judo Canada.
- PD points will not be pro-rated. The LOCKER will automatically reduce the required points for each coaching level to zero as activities are recorded. This would make it possible for a coach to acquire all the necessary points in year one and then not do any further upgrading for the rest of the period. Current period for Professional Development is 5 years.

#### Shodan Grading and the NCCP update reminder:

- The CAC agreed that Shodan evaluation in judo meets the criteria of a formal evaluation for the NCCP module "Teaching and Learning Judo Skills" (credited with "In Training" status).
- In order for this to happen, all Shodan recipients must be recorded in the CAC database, which can be done only by NCCP facilitators. As such, all successful Shodan grading must be followed by the CAC database registration. The MLF must have the following data for this to happen:
  - Name, first and last
  - o CC # if available
  - o Full address, with postal code
  - Date of Birth
  - o Phone number
  - Active and unique email address

#### DA and DI course and certification reminders:

- DA normal process:
  - o Take a course with Ethical Decision Making, Teaching and Learning
  - Coach for a minimum of 60 hours
  - Certification after the practical examination, once passing the on-line MED exam, 16 years old and sankyu (green). Certification practical exams must be a minimum of 45 minutes and must include a properly developed LP and a functional EAP
- DI normal process:
  - Take a DI course with Lesson and Season Planning, Basic Nutrition, U7/U9 Active Start and U11/U13, Learn to Train
  - o Coach a minimum of 120 hours
  - Certification practical examinations must be a minimum of 60 minutes and must include a properly developed LP and a functional EAP. The coach must have passed the on-line MED, be 19 years old, Ikkyu (brown) and trained DA.

# Judo BC Referee Committee 2012-2013 Annual Report

June 2013

The Judo BC Referee Committee is very appreciative to all participating Referees, and grateful for your commitment, time and dedication to promote and advance our sport. Thank you very much and we look forward to your continued support.

#### **New Rule Changes/Seminars/Clinics:**

The 2012/2013 season started off on the run, with the 2012 Annual Referee Seminar held in Salmo, September 14 – 16, 2012. There were 12 participants from the various Kootenay clubs and from the Okanagan and Cariboo areas. The focus was on the grassroots, back to the basics.

I would like to thank Sandra Vaughn-Sydham and Salmo Judo Club for hosting the seminar. A special thanks to Donna Hanson, a recent returnee to BC from Alberta, for providing her insight and support.

The location of the 2013 Annual Fall Referee Seminar has tentatively been set for Kamloops.

As you know, the IJF had posted in 2012 the updated IJF Refereeing Rules on its website. These Rules were reproduced into pocketsize books and the first books were made available in Salmo.

Nanaimo was host to the November 2, 2012 Kata/Referee Clinic which included 19 participants. Ron Kuramoto presented the Referee portion of the clinic which also focused on the grassroots, back to the basics. We would like to thank the Nanaimo Judo Club and Grading Board for including the Referee Committee in this program.

Suddenly the latest IJF Refereeing Rule book was obsolete! The IJF announced further changes [mainly no gripping/blocking below the belt] in late 2012. The first introduction of these rule changes was made at the Pacific International in February 2013 by Guy Sunada, chairman of the Judo Canada Referee Committee. The implementation date had not yet been set – best guess, at that time, was April 2013.

On February 23, 2013 I attended the regional Invermere Judo Tournament and was pleased to see that this region was ready to implement most of the new rules. With the help of Bruce Kamstra, the new rule changes were reviewed at this tournament.

The tournament went very well, thanks to the good organizing led by the Herman Mauthner, Bob Gadsby and Fred Geitz. You and your crew did a very good job.

The Edmonton International was the first major tournament to implement the latest rule changes. The athletes seemed to adjust very well. From my observations, many of the referees were overwhelmed with the introduction of the latest rules changes, being subjected to the referee video replay and the brief testing of the one-referee system. It was observed that the replay system often slowed the matches considerably, adding to the length of the tournament.

At the following Ontario Open in May 2013, the one referee system was tested further. While on the surface, this new system was well received, there were problems that had to be overcome.

The latest news is that one referee system will be used at the upcoming 2013 Nationals.

#### Judo Canada – Roster of Referees:


A National A or higher level referee must be listed on the Judo Canada Roster of Referees to be eligible to officiate at a Canadian Nationals and Canada Winter Games. Also, a referee must be listed to be eligible for higher evaluation and to officiate internationally.

In order to remain on the roster list, the Judo Canada Referee Committee requires all listed referees to be re-evaluated at qualifying tournaments within 4 years of being last rostered.

Article 6.2

4) The President, Second Vice-President and *Treasurer* must be elected in years not evenly divisible by two. The First Vice-President and *Secretary* must be elected in years evenly divisible by two.

This is a housekeeping item to align the positions up for elections each year with the current election practices.
