

### **BASIC RULES OF ORDER FOR SOCIETIES**

The following are basic rules of order, which may useful to societies that have not adopted rules of order in their bylaws or otherwise. The bylaws determine many key procedural matters, but often don't say anything about rules of order – Robert's Rules of Order <u>don't</u> automatically apply, and can be challenging to understand and apply.

These rules should not be used without considering whether they are consistent with what the bylaws require, and amendment as needed. If they are used, they should be approved by ordinary resolution at the start of a general meeting – unless the bylaws state otherwise, a meeting has the power to determine its own rules and procedures.


If these rules are used, they should be approved by ordinary resolution at the start of the meeting.

- 1. The meeting will be governed in accordance with, in order:
  - a) The Society Act, and any other applicable laws.
  - b) The constitution and bylaws.
  - c) The following rules.
- 2. Democratic principles, the rule of law, an orderly meeting that addresses the business at hand, and common courtesy are paramount. The meeting is only for the purpose of transacting the business of the society and its members.
- 3. Only voting members in good standing have the right to speak, to make motions, and to vote. Other persons attending may speak at the discretion of the chair. Each member present in person or by proxy has the right to vote on every issue.
- 4. A member who wishes to speak should wait to be acknowledged by the chair, and begin by stating her/his name, and any other pertinent information.
- 5. A motion or resolution must be seconded before it can be debated.
- 6. The person moving a motion or resolution has the right, except for undebatable motions, to speak for up to five minutes at the start of debate on it, and for up to two minutes at the close of debate on it. (An undebatable motion usually relates to procedure, and is voted on without debate.)
- 7. Each member has the right to speak twice to a motion or resolution, for no longer than three minutes each time. A member may only speak a third time, or for longer than three minutes, if allowed to by ordinary resolution.
- 8. A member can only speak a second time on a motion or issue when all members who wish to speak to it a first time have spoken.
- 9. Discussion, comments and questions must relate to the pending motion, report or issue. All other matters will be referred to the appropriate part of the agenda, or new business.
- 10. Debate on a motion may be closed by general consent, or by a motion to close debate. Such a motion is not debatable, and must be approved by a 2/3 majority.
- 11. A special resolution has the effect of amending the constitution or bylaws, and so is binding on the organization and the directors. Such resolutions cannot be amended, and must be approved by 75% of

all the members present. There must be at least 14 days written notice of all special resolutions to all members.

- 12. Ordinary resolutions include all resolutions notice of which has <u>not</u> been given. They cannot change the constitution or bylaws, and may not be legally binding on the society, except for elections and other matters specified in the bylaws or the Society Act. They must be passed by a simple majority more members vote in favour than are opposed. The chair may require that the mover of an ordinary resolution write it down before it can be debated.
- 13. Voting is by show of hands, unless a secret ballot is required by the bylaws, or when so decided by a simple majority of the voting members present. A secret ballot must be requested by or before the end of debate on a matter, and the vote on the request must be made by show of hands.
- 14. A motion to adjourn is always in order, and is not debatable.
- 15. Any procedural question not addressed by the Society Act, the bylaws, and the foregoing, will be determined by the most recent edition of Robert's Rules of Order.

  - b) Assurances that the database will ensure all data required by Judo BC will be collected by the system.
  - c) If (b) is not deliverable, assurances that Judo BC can proceed with the development of its own database with an eye on providing to Judo Canada the required membership data in a csv file which can be uploaded into their eventual system.
- 2. Judo BC is concerned that a loss in funding by Judo Canada following the 2012 Olympic Games may result in an increase in membership's fees. Judo BC requests that a careful analysis be taken by Judo Canada prior to institution any additional costs to the provinces which may have a negative effect on membership growth with the provinces.

  - Discussion regarding the possibility of hosting a morning or afternoon MED workshops. Goal would be to invite all coaches who required the MED to attend and work together on getting this task completed.
  - iv. Judo BC has secured \$2,000 in funding to help with facilitator training. See report for details on learning facilitator development.
- c) BC Winter Games Committee Chair
  - i. On target to meet coaching and officiating requirements
  - ii. Club support has been good with regards to athlete identification. Concerned about the lower mainland. Will have a better idea once the trials are completed. Chair is confident we will meet our participation requirements.
  - iii. Discussion about possibly eliminating a weight division in the next games to the low number of participating in this division. Chair to speak with wrestling about their challenges with lightweights.
  - iv. Working on identify 2 referee for certification.
  - v. Abby Lloyd and Ashley Bartlett will be the 2 female coaching apprentices for the games.
  - vi. Hosting a coaching seminar and technical session following the games. Details are forthcoming.
  - vii. Discussion about possible financial support for need based participants.

- f) CRA
  - Invoiced \$1,575.49 for HST owing (plus interest) based on the audit completed for 10-1-2010 to 12-31-2010 and 01-01-2011 to 03-31-2011.
  - We are now tracking HST collections on all NCCP courses and referee clinics for quarterly remittance to the government.
  - We have filed an application for GST/HST public service bodies' rebate for the following last four quarters total \$9,219.61. As rebates should not be applied as revenue for the fiscal year, we recommend that any rebates received by Judo BC be deposited into the contingency fund.
  - Although successful with our rebate applications, we cannot collect the funds as we are apparently not compliant with CRA regulations. Apparently we have no file any corporate income tax report since 1964. Our accountants believe there may be some confusion within the CRA. We have filed the appropriate paper to give Loren, Nancke and Company the authority to deal directly with the CRA on our behalf on this item. We expect an update in the next few weeks.
- g) Online Registration and Credit Card Payment
  - Met with Patrick Esparbes of Judo Quebec to discuss. We are currently working on duplicating the Judo Quebec system which allows members to register on-line and pay with their credit card via PayPal.
- h) Auditor Search Update

Further to our last meeting, the Executive Director sent out a request for proposal. The board reviewed the 4 proposal received by the deadline:

- EPR Coquitlam
- Reid Hurst Nagy Inc.
- Wolridge Mahon Chartered Accountants
- D & H Group.

After discussion and deliberation, the board directed the ED to secure EPR Coquitlam for the March 2012 Audit.

Outstanding debt of \$200 has been remitted as well as \$100 for the current season. The club must now complete the 2011-12 club registration forms in order to regain their member in good standing status.

k) Year End Budget Projections

- i. We need every chair to review their line items in the budget and flag any concerns with regards to the yearend projections so that we may take immediate remedial action.
- Membership. Our figures currently show an overall decrease of in registration of 22.8 %.
   However, we have three clubs who have yet to submit their registrations Nakashima,
   Surrey and Cranbrook.

\*2010 figures as of Nov 25<sup>th</sup> were \$104,445 in membership registrations.

iii. Currently projecting a deficit. However, we have funds in the membership committee area which have yet to be earmarked for a specific project. These will remain "unallocated" until such time as we feel confident that we have an accurate projection from each program area AND have received confirmation of our Hosting BC Funding Allocation as we have made commitments to the Steveston Judo Club to assist them in securing funding for enhancement we are making to the Pacific International.





The participation of the subsidized individuals may be negatively affected if not subsidized their participation. Their participation in the Games can be translated into a 7% increase in our athlete participation numbers and increases in previously poorly represented zone such as 1 and 7. It is also important to note that 3 of the 8 are girls, which still an area that could use improvement in our statistics.

The investment of \$800 will help strengthen our overall participation number and will results in Judo BC exceeding the target identified by the BC Games Society in their last probationary report.






# Report on Judo Canada Women's Leadership Committee February 22, 2012



- I. Committee members
  - i. We have expanded the committee members since our last meeting. Currently the following people have additional accreditations or have been added to the committee:
    - Current certified members for both DA and DI levels, course delivery and evals:
      - 1. Bruce Fingarson, Chair
      - 2. John Huntley
    - Newly added member:
      - Fred Gietz (Zone 1) has been accredited with his level III certified at the December meeting of the Judo Canada NCCP committee. Fred is newly certified for DA course delivery and we are working on his DI course delivery and coach evaluations.
    - New LF accreditations:
      - 1. Bruce Kamstra, certified to do evaluation for DA trained coaches. Bruce K. needs to participate in running a DI course with the MLF and then to do DI evaluations under the MLF's mentorship.

### II. Season plans

- i. Current schedule for DA courses:
  - The committee has applied for funding to support an all female DA course in the lower mainland. The Coaching Association of Canada is offering the funding to encourage more females into the coaching ranks. ### IV. NCCP development

- i. Jonathan Lavoie-Copeland, Information Technology Manager for CAC came to BC (Coach BC office) to discuss the current status of the CAC database. The new access to the database is through a web page called the Locker. Highlights of the Locker are:
  - Judo is in the 3<sup>rd</sup> release out of 6 for rollout, paced 2 to 3 weeks apart
  - Due to Judo's specific details (i.e. a DI course gives credit in two competencies), the data base backlog was very large. To date there is still outstanding data that is being worked on to clean it up and to input.
  - Contrary to the past database, the Locker reflects up to date data in the system by generating the transcript in real time from the data.
  - The PSO will have more power to correct data errors and to update the data through direct access and a soft copy approval process.
- ii. Meeting at Judo Canada, Ottawa on December 10<sup>th</sup> to review all aspects of the NCCP program and courses, minutes attached.

NCCP meeting in Ottawa for NCCP review.

Meeting took place at the Judo Canada office on 10, 11 December, 2011.

Attendees:

Agenda items:

### Special cases:

- Fred Gietz will be given equivalency for level III and when it can be changed in the data base (under the Locker hopefully) it will be changed. BF can move forward with Fred on the DA LF process in Campbell River. Judo BC can activate the Coach BC supported program for both Bruce K. and Fred G.
- Japanese and Korean coach from Bby dojo: support from Judo BC Coach Development committee for challenge of the DI equivalency. Judo BC may waive the fee (this will be raised to the Judo BC Board for decision).
  - Master Learning Facilitator for BC (currently Bruce F.) to do the evaluation: after observing and commenting on some lessons (probably two lessons prior to the evaluation) from each of the coaches. Chair of CDC (Coach Development Committee) to provide logistic paths for these two coaches. This must include successful completion of the on line MED, signed Code of Conduct and the evaluation process pre-briefed.
- Judo BC CDC short term developmental plan will be Bruce K. as LF evaluator in PG, Fred G. in Fernie as a DA LF, John H. in Kamloops as full DA/DI LF and Bruce F. on the coast as full DA / DI LF.

### PEI request to fix admin errors:

• Due to PEI politics, some coaches have not been entered into the data base and have no supporting documentation. It is the decision of the Judo Canada committee to grant DA trained status for any of these coaching issues.

### Schedule for DI course variances:

• All agree that the course length can't be shortened. Manitoba does the course as stated on their website by sending home homework with the coaches and then following up to get the

homework back. This creates a logistic problem with CRF's currently, but with the new Locker this may be resolved as PSO, MLF or CDC committee chair can enter the completion as the coaches submit work. This will be reviewed after training of the Locker and this training passed down to the PSO. Need to ensure that the PSO's get as much access as possible with the PSO distributing and responsible for the access of each of the Judo BC CDC members.

#### How to address the current harassment issues and report due to these issues:

- Issue with harassment: a case has come up and Judo Canada hired a harassment office to review the case. The coach involved was charged and has been released, and is still coaching while waiting for the trial. The report of the officer included recommendations that Judo Canada is trying to implement. The question is how to communicate this better than it is currently being done. Perception has to be transparent communication.
  - All coaches must have a criminal records check starting in 2011 season, but is not mandatory and is recommended by Judo Canada. It will be up to the Province to mandate. This should be a Judo BC Board agenda item.
  - All coaches will be required to sign the Judo Canada Code of Conduct. This Code will be added to the NCCP policy as an appendix.
  - Other suggestions occurred to improve visibility such as a parent section on the web site with information including concussion, harassment, process for each coach (i.e. signed Code of Conduct, criminal records check, etc.), suggested supplementary courses such as "Respect in Sports" (Manitoba mandates this). Raise this issue to the Judo BC Board to discuss.

### Level III & IV and gradation standards:

NCCP Canadian Chair is working to develop a national gradation standard for both the DA and DI competencies. Lots of input during the meeting and Andrzej has notes to include in the policy which then will need to be approved by the JC Board. These discussions included Level III challenges and the process for certifying Level III as well as Level IV. More information on this topic to come. It is suggested that the evaluation will include a review of the coach's portfolio, an interview with the candidate and a field evaluation. The field evaluation would include a 360 degree review with discussions from athletes, peer coaches and others to get feedback for the in-field portion.

### **Review of NCCP policies:**

A quick review was done and some changes to the policy were drafted into the policy. Andrzej will formalize the changes and will pass out for comments prior to approval by the Board. There were no comments on the price charged for courses as no one has received complaints. Andrzej pointed out that Tennis Canada charges over \$1000 for the two courses (DA and DI). It was agreed that the current prices would stand. Discussion around compensation occurred. Bruce F. will discuss a suggestion to the Judo BC Board to approve the full evaluation fee to the evaluator as this is done in other provinces. If this occurs, then how do expenses for multiple

evaluations get calculated and compensated knowing that a coach can submit a dvd of the practice. Raise to the Judo BC Board for discussion.

- Current names of DA and DI have not had complaints from across Canada, even after a survey went out. The names will not be changed due to the process, logistics and complications with CAC. Level III and above names were discussed and some of the suggestion would be Comp-Dev National, Comp-Dev World and Comp-Dev Olympic (or something like this)
- Level III equivalency is proposed as follows:
  - Legacy theory only 2 out of the 6 required module credited (Andrzej will provide which two modules, he could not recall during the discussions which ones)
  - Legacy theory and technical equivalency to Trained status
  - Legacy certified certified to Comp-Dev plus a requirement to perform PD activities of the Performance Analysis and Seasonal Development modules.

### MLF and LF development and accreditation support:

• This was discussed and more pro-activity will be required in the future due to CAC policy around the LF's and MLF's. No timing on this was available.

#### **Comp-Dev pilot information:**


- Comp-Dev (old Level III): Toronto with 10 people in 2010, and Montreal with 20 coaches in 2011; The next course will be in the summer of 2012 in Montreal in French and following that will be in English in the summer of 2013, venue to be determined, but probably will be in Ontario. There will be one Comp-Dev course per year, alternating English and French.
- The evaluation process was discussed and a logistical plan devised. This complete package of evaluation process will be included in the policy and will be distributed for comments prior to approval.

### Shodan DA In-Training equivalency:

- We were reminded about this equivalency and how it would impact the DI course abilities (not all coaches will have gone through any NCCP courses, so the DI course needs to have a review element). Will need to discuss this with the Judo BC CD committee to formulate a plan.
- Judo BC CDC Chair will have to coordinate the list of people (with the Chair of the Grading Committee) who grade for Shodan for each of the two grading's in the year to ensure these coaches get put into the CAC data base.

## Coaching Report

March 2, 2012

The BC Team travelled to Regina for the Sask Open and training camp in January. We had 4 athletes and brought Lisa Nakajima as a development coach. Abby Lloyd won Gold in U17 and U20. Kristi Roots won Gold in Senior and Bronze in U20. Kurt Roots won silver in U17.

Taking small teams on these events have great value. We are able to concentrate our efforts on a few individuals instead of just managing large teams. This is important when we look at developing our top athletes. If we can also get a training session in while we are away, it is even more beneficial.

The Pacific International was well supported this year and we had over 150 participants on the mats for Sunday's training led by former World Champion, Nakanishi Sensei.

The selection process has begun for both the Senior and Junior BC Teams. The final selection tournaments for the Junior team are the Youth Provincials/camp in Kamloops March 3-4 and Edmonton International March 31. Edmonton will be the final selection tournament for the Senior team and both teams will be finalized shortly after this.

Finally, we have the Ontario Open and Inter-Provincial camp as final prep events prior to the first ever combined Canadian Championships. We are anticipating supporting our Senior top 5 athletes and U20 medallists for the Ontario Open. We also want to organize a bus from the lower mainland to Canmore for our training camp with Alberta and Saskatchewan June 1-3.

Our accountant have researched the matter and have concluded that as we are an incorporated not for profit, a corporate tax return should have been filed each year by the auditors. For some reason, our previous auditors did not submit the return nor direct the Judo BC to do so. Our new auditors are currently preparing the return dating back to 20078 at a cost of \$600 plus HST. The CRA is currently withholding \$11,748.94 in rebates. These funds ought to be released to Judo BC once our account has been declared in good standing.

- As documented in our 3<sup>rd</sup> Quarter Compliance Certificate, EPR Coquitlam prepared our 2008, 2009, 2010, and 2011 corporate tax returns in order to our corporate account with the CRA in good standing.




Call was convened by the President to inform the Board of the Disciplinary Panel's report and to discuss next steps.

### 1. 2011-12 final budget as of March 31, 2012 (Appendix A)

The Executive Director presented the budget as of March 31, 2012 which was provided to the Auditors to prepare the audited statements.

### 2. Approval of the 2012 - 13 budget (Appendix B)

The Executive Director presented the proposed budget for 2012-13. Highlights:

- a) Increase on coaching development income and expenditures are due to the coaching conference schedule for October 26-28, 2012.
- b) Increase in the athlete development area reflects the projected expenditures and income versus simply the investment made by Judo BC.
- c) Judo BC has reached an agreement with Steveston which will see the budget for the 2012 Pacific International moved to Judo BC. A budget for 2012 along with a profit sharing formula will be developed over the next few months.
- b) A separate revised budget for the 2013 nationals will developed and presented to the board for approval in the next few months.

Moved by Bruce Fingarson, seconded by Al Hadvick to approve the 2012-13 budget has presented.

### 3. Fall Coaching Conference

Sandy Kent provided an overview of the conference proposed for the fall:

- Ad Hoc Committee composed of the Provincial Coach, President and Executive Director have been working on the planning aspect of the event. The dates will be Oct 26 to 28
- Venues considered: Harrison Hot Springs Resort and Spa, Hilton Whistler Resort and Spa, Executive Airport Plaza Conference Centre and the Executive Suites Garibaldi Springs Resort. The Committee eliminated Richmond in favor of a more "seclude located". Harrison was eliminated due additional costs and time required to coordinate ground transportation from YVR.
- Committee is recommending the Executive Suites Garibaldi Springs Resort location for the following reasons:
  - Limited risk to Judo BC we do not have to guarantee a minimum number of room bookings or meal plan purchases.
  - The room rental is \$20 less per night with free parking and internet services. Overall savings to participants is \$150.
  - The hotel is providing us with a 10% commission on all room bookings and 1 free room for everyone 20 sold.

## 4. Chair of Ad Hoc Committee on Membership Data to give quick overview of Saturday's session.



### 3. Selection tournament/camp bid -

Committee agreed to move the selection timetable up in order to announce the selection tournament and 2013 BC Youth Championship Host at the AGM.

Action: The Executive Directors was directed to update and circulate the selection criteria and application forms before the end of April.

Draft 2012-13 criteria and application forms can be found in appendices A and B.

### 4. Judo BC Tournament Standards document

The Committee discussed a few additional modifications to the standards (i.e.: pool system format).

Action: The Executive Director to circulate the information to the Board of Directors for approval once the revisions are completed by the Chair.

### 5. Youth Provincial Championships

Committee voted to keep the championship closed. They also approved that athletes can compete in more than one division.

Host club can raise the entry fee to \$50 (camp and tournament) and host must pay to participation fee to Judo BC.

### 6. 2015 CWG Selection Criteria

General discussion regarding possible competition and training camp opportunities.

## Action: Bruce Kamstra to develop selection/training plan and forward to the Committee for feedback.

### 7. Selection criteria for provincial team

The committee discussed possible changes to the selection criteria for 2012-13, such as Edmonton.

Action:	Chair to draft proposed 2012-13 selection criteria and circulate to committee
	for approval.

### 8. BC Winter Games

Committee agreed that the national medal clause for the U15 group should be removed.

## Action: Chair to discuss this item with the BCWG Advisor once Judo BC received notification that it has been removed from probation.

### 9. Team selection

Committee reviewed the list of qualified/funded athletes for the 2012 nationals (senior and junior). They also approved proposed funding levels and provided feedback on the selection notification letters.

# Action: Executive Director to circulate the selection notification letters and list of qualified/funded athletes to each club. The information is to also be posted on the website and listed in the e-newsletter.



### A. Judo BC Fall, Winter and Spring Training camps

- Mat space must be able to accommodate up to 100 athletes.
- A \$25 camp fee will be charged per athlete and will be payable to Judo BC. The camp host will receive 50% of the camp entry fee to assist hosting cost related to the event.
- Provincial Team points will be awarded to athletes who attend all practices of the training camp, partial points if they miss one or more practice.

### B. Judo BC Summer Training camps

Judo BC will be offering a summer camp in August 2012 (team points not assigned to summer camp). The camp will be held in Abbotsford (Abbotsford Judo Club / Columbia Bible College).

### **C** Selection tournament criteria:

- Must be sanctioned by Judo BC in accordance with the tournament sanction policies and procedures.
- > Selection tournament dates must not conflict with Judo Canada points tournaments.
- > Entry fees are paid to host club, not Judo BC.
- > Host club is responsible for all costs associated with the shiai.
- Host club must collaborate with the Referee Commission to ensure high level referees are available for selection divisions.
- A BC Team Practice held on Sunday after shiai can be held at host dojo if it will accommodate numbers (min 75 athletes and coaches). Athletes will receive 2 points for attending Sunday Team Practice.
- Junior and Senior tournaments may be combined, but junior selection tournaments must be held after January 1.

### D. BC Youth Championships and Training Camp (spring)

- Although Judo BC plans on rotating the location throughout the province, clubs must still bid to secure hosting rights.
- > Must follow all Judo BC sanction rules and regulations.
- Minimum 2 mat areas.
- > U20/U17/U15 (may include U13 for development purposes) only.
- Minimum rank for all athletes is yonkyu (orange belt) and minimum age is 11 years old. Written approval from club sensei and parents is required for all U13 athletes. Approval must be received with tournament registration information.

- Host may offer a U9 and U11 division. However, this division must be held separately on a third mat area.
- Athletes may only compete in their own age/weight category. Exhibition matches may be arranged if there are insufficient numbers in any weight categories. Coaches to discuss with Tournament Director.
- Host club to book host hotel, secure reasonable sport rate for athletes and their families, meeting rooms for weigh-in (male/female).
- > Weigh-in to be held at host hotel, unofficial scale available on Friday evening.
- Unofficial weigh-in Saturday 6-7am, official weigh-in 7-7:30am, shiai start time 9:30am (same as nationals).
- Training camp Saturday afternoon and Sunday morning
- > 10 points for attending camp, additional points for shiai placings
- > \$50 entry fee includes camp and shiai
- Host must pay "Judo BC Participation Fee" and "Judo BC Tournament Sanction Fee"
- Shiai/training camp support provided by Judo BC
  - Judo BC to provide medals
  - o Judo BC Head Coach will oversee the delivery of training camp

### **E. Selection Process:**

The Technical Committee is responsible for selecting host clubs for each training camps, selection tournaments and youth championships. The selections process takes into consideration the strength of the bids submitted and as well as the following:

- Conflicting dates with Judo Canada events and other major tournaments
- Conflicting dates with stat/school holidays, etc.
- Available accommodations in local area

Applicants will be sent an email by the Judo BC Office confirming receipt of their bids.

The Judo BC Office will notify all applicants of the final hosting assignments within 24 hours of their selection meeting.

### F. Application deadline:

Bid must be received by the Judo BC Office no later than 4:30pm on Monday, May 21st, 2012. Incomplete bids will not be forward to the Technical Committee for review.

#### To be considered for the Judo BC Junior Team and to be eligible for Judo BC funding, junior athletes must:

- 1. Attend minimum of two selection training camps (fall, winter, youth provincial camp, spring inter-provincial);
- 2. Attend minimum of two junior selection tournaments (listed above);
- 3. To be considered for Judo BC funding for *any* out of province competitions (i.e.: Ontario Open, Quebec Open, etc.), athletes must medal at the previous junior nationals and have won at least 2 matches at the junior nationals;
- 4. Judo BC reserves the right to fund the top athletes in each division based on most points, subject to available funds. All divisions may not qualify.
- 5. Athletes may attend the national championships on a <u>self-funded basis</u>, provided they meet the <u>minimum</u> Judo BC Selection Criteria as follows:
  - Must attend the Judo BC Youth Championships and training camp; and
  - Must attend 1 additional selection training camp or 1 additional selection tournament before team selection is finalized in April.

#### To be considered for the Judo BC Senior Team and to be eligible for Judo BC funding, athletes must:

- 1. Attend 1 training camp and Ontario International or 1 training camp and Quebec Open; or
- 2. Attend minimum of 3 tournaments listed above;
- 3. Judo BC reserves the right to fund the top athletes based on available funds;
- 4. To be considered for Judo BC funding athletes must place in the top 5 at the senior nationals and win minimum 2 matches at the senior nationals;
- 5. To be considered for out of province funding, athletes must attend the Senior Nationals and Training camp ;
- 6. Athletes may attend the national championships on a self-funded basis, provided they attend 1 training camp and 2 tournaments from list above.

#### Veterans

Athletes interested in competing in the Judo Canada Veterans National Championships must submit their name to the Judo BC office by **April 1** each year. Names will be forwarded to Judo BC Head Coach and Technical Committee for review.

- Athlete information required: name, year born, age category, weight category, exact weight, telephone number(s)
- Participant at nationals is on a self-funded basis.

#### Katas to be judged:

Nage No Kata, Ju No Kata, Katame No Kata, Goshin Jitsu, Kime No Kata

- Kata pairs must compete as a team at the selected provincial Kata competitions as published on Judo BC website
  - Judges must consist of minimum one Grading/Kata Board member and two additional judges selected by Provincial Grading/Kata Board
- Teams must participate in at least 1 kata clinic between October-March;
- Teams wishing to compete at the national kata championships must submit their names in writing to Judo BC and the Chair of the Grading/Kata Board by **March 1**;
- Final team selections decided by Judo BC Technical Committee, based on recommendations from provincial Grading/Kata Board;
- Judo BC may provide funding for the top ranked kata teams, subject to available funds.

### **Rules and Regulations For Selection To All Provincial Teams**

- 1. Each team (Junior, Senior, Veterans, Kata) may have additional rules for selection; please refer to specific team criteria.
- 2. Team points  $1^{st}$  place 10,  $2^{nd}$  place 7,  $3^{rd}$  place 5
- 3. 2 points will be awarded to athletes who attend the Team BC workout on Sunday following selection tournaments.
- 4. Athletes must attend the minimum number of events in order to be selected or receive funding for junior or senior events (refer to team selection criteria).
- 5. Athletes who make a change in weight category during the selection process will carry 50% of their points earned from previous weight category counted in the calculation of their total points standing.
- 6. Training camps 10 points athletes must attend all practices to receive full points for training camps. Partial points will be given to athletes who miss one or more practice.
- 7. Camp fees to be paid at the camp, not mailed in. One club cheque for all participants, do not pay individually.
- 8. Athletes must sign-in for all practices at training camps.
- 9. Athletes must win at least one (1) fight in order to receive points (except in the case where there is only one entry in a division).
- 10. In BC competitions that have out-of-province competitors, points will be awarded to the highest placing BC competitors (i.e. 3<sup>rd</sup> place finish but highest BC athlete would receive 10 points for 1<sup>st</sup> place).
- 11. In the case that athletes are tied in points OR in cases where athletes have been awarded special consideration by the Technical Committee, fight-offs may be held. Judo BC will contact those who could potentially be required to participate in a fight-off prior to the date, including athlete's personal coach. Cost for attending the fight-off is borne by the participants.
- 12. Final team selection will be communicated by Judo BC to all clubs following the last selection event or selection deadline for each team (jr/sr/veteran/kata).
- 13. Application for all special circumstances must be communicated to the Judo BC office <u>prior to the day of the event</u>. Where that communication is verbal, the athlete will follow-up within seven days with written documentation as required (e.g. medical certificate).
- 14. Injury exemptions will be considered on a case by case basis by the Head Coach in consultation with the Technical Committee. To qualify for an injury exemption, the athlete, parents or personal coach must notify Judo BC as per the Special Circumstances clause above. A medical note must be provided. A medical certificate signed by a physician must be provided stating the nature of the injury, the date the injury occurred and the anticipated date of return to training and competition.
- 15. If an athlete receives a medical exemption, he/she will receive participation credit for that event. Follow-up documentation may be required from athlete's doctor before he/she can compete in the next event.
- 16. If an athlete is injured during competition, his/her coach or parent must ensure the withdrawal is documented on the tournament draw sheets for recording purposes.
- 17. An athlete selected by Judo Canada for an international or junior developmental event that is in conflict with a provincial selection event date will receive the equivalent of first place points according to the provincial points table for the event in conflict. Conflict of dates will include 14 days prior to and after the international event.
- 18. Athletes training full time outside of the province or competing in approved out-of-province tournaments <u>may</u> be exempt from competing in selection events in divisions provided that they make a special application in writing to the Judo BC office. Decisions will be made on the strength of the weight class within the province as well as the applicant's placing at the previous year's Provincial selection events and the National Championships.

- 19. The National Champion for the previous year (if still in the same weight and age class), and nationally carded athletes will be automatically selected providing they participate in the Provincial Selection process.
- 20. An athlete with a current proven competitive record from another province who relocates to BC during the competitive season may be considered for selection. Application must be made to the Judo BC office prior to the final selection event.
- 21. To receive funding, all athletes including National Champions and Carded athletes must participate in the Provincial selection process and designated training camps as outlined above.
- 22. Funding for any event is strictly based on the availability of funds from the Judo BC Athlete Development budget.
- 23. Athletes who do not qualify for Judo BC funding may attend the Judo Canada National Championships on a selffunded basis, provided they meet the Judo BC Selection Criteria as outlined above.
- 24. All athletes that are part of the Judo BC talent pool are under the rules and disciplinary procedures of the Judo BC Policy and Procedures (copies of this policy are available from Judo BC at <u>info@judobc.ca</u>). All athletes are required to abide by these rules and regulations and shall agree to do so by signing the Athlete Code of Conduct before accepting a position on the team. A parent's signature is required for minor athletes.
- 25. Parent(s) of minor athletes are expected to abide by all rules and regulations contained in the Judo BC Selection Criteria (deadlines, athlete's curfews, etc.). A parent's action which causes an athlete to breach the Code of Conduct will not be considered as grounds to dismiss any disciplinary action on the part of Judo BC.
- 26. Athletes must abide by the rules within the Athlete Code of Conduct as articulated in writing by the Head Coach, Coaching Staff and Judo BC. Any violation of these rules and regulations may be dealt with on site at the discretion of the Coaching Staff. Breach of rules and regulations shall also be dealt with in accordance to the Judo BC Policy and Procedures. Copies of Judo BC's Policy and Procedures can be found on the Judo BC Website – <u>www.judobc.ca</u>.
- 27. All athletes must be in good standing with Judo BC in order to be selected to a team for any event.
- 28. Athletes who fail to meet required deadlines, submit a signed Code of Conduct or remit payment for costs associated with their selection may forfeit their right to selection.
- 29. All Judo BC talent pool athletes are encouraged to attend regional training sessions and/or regular team workouts in their area.
- 30. Judo BC reserves the right  $\underline{not}$  to select a full team for any event.
- 31. All selections are subject to the approval of the Judo BC Technical Committee.

# JUDO BC Selection Criteria to host a provincial selection tournament or selection camp 2012-13

# A. Judo BC Fall, Winter and Spring Training camps

- > Mat space must be able to accommodate up to 100 athletes and coaches.
- A \$25 camp fee will be charged per athlete and will be payable to Judo BC. The camp host will receive 50% of the camp entry fee to assist hosting cost related to the event.
- Provincial Team points will be awarded to athletes who attend all practices of the training camp, partial points if they miss one or more practice.

## B. Judo BC Summer Training camps

Judo BC will offer a summer camp in August 2012 (team points not assigned to summer camp). Camp registration info available on the Judo BC website.

# C. <u>Selection Tournament Criteria</u>

- Tournament must be sanctioned by Judo BC in accordance with the tournament sanction policies and procedures. Refer to Judo BC Selection Tournament Standards Policy.
- > Selection tournament dates must not conflict with Judo Canada points tournaments.
- > Entry fees are paid to host club, not Judo BC.
- ▶ Host club is responsible for all costs associated with the shiai.
- Host club must collaborate with the Referee Commission to ensure high level referees are available for selection divisions.
- Host club must provide Technical Committee Chair with a copy of draw sheets for all selection divisions at the end of the shiai so Team points can be tallied.
- A Team BC practice will be held on Sunday after shiai can be held at host dojo if it will accommodate numbers (min 75 athletes and coaches). Athletes will receive 2 points for attending Sunday Team Practice following selection tournaments (jr and sr).
- Junior and Senior tournaments may be combined, but junior selection tournaments must be held after January 1.

## D. <u>BC Youth Championships and Training Camp (spring)</u>

- Judo BC will rotate the location of the Youth Championships throughout the province. Clubs must bid to secure hosting rights each year.
- ▶ Host club must follow all Judo BC sanction rules and regulations.
- Host club must produce a Youth Championships Technical Package to be sent to all clubs. Contact Judo BC for further information.
- > Youth Championships and camp only open to Judo BC athletes.
- Minimum 2 mat areas.
- ▶ U20/U17/U15 (may include U13 for development purposes) only.

# Judo BC Selection Criteria to host a provincial selection tournament or selection camp

- > Minimum rank for all athletes competing in U15/17/20 is yonkyu (orange belt).
- ▶ U13 athletes may compete in U15 (minimum age is 11 years old).
- Athletes may compete in up to two age categories, their own plus the next age group (ie U15 athlete may compete in U17, U17 athlete may compete in U20).
- Host club to book host hotel, secure reasonable sport rate for athletes and their families, meeting rooms for weigh-in (male/female).
- > Weigh-in to be held at host hotel, unofficial scale available on Friday evening.
- Unofficial weigh-in Saturday 6-7am, official weigh-in 7-7:30am, shiai start time 9:30am (same as nationals).
- > Training camp Saturday afternoon and Sunday morning.
- > 10 points for attending camp (all practices), additional points for shiai placings.
- ▶ \$50 entry fee includes camp and shiai
  - o Host club must pay Judo BC participation fees
- Shiai/training camp supported by Judo BC
  - Judo BC to provide medals
  - o Judo BC Head Coach will oversee the delivery of training camp

## E. <u>Selection Process:</u>

The Technical Committee is responsible for selecting host clubs for each training camp, selection tournaments and youth championships. The selections process takes into consideration the strength of the bids submitted and as well as the following:


- Conflicting dates with Judo Canada events and other major tournaments
- Conflicting dates with stat/school holidays, etc.
- Available accommodations in local area

Applicants will be sent an email by the Judo BC Office confirming receipt of their bids.

The Judo BC Office will notify <u>all</u> applicants of the final hosting assignments within 24 hours of the selection meeting.

## **F. Application deadline:**

Bid must be received by the Judo BC Office no later than 4:30pm on Monday, May 21st, 2012. Incomplete bids will not be forward to the Technical Committee for review.



#### Athlete of the Year Award

#### 1. The Award:

a. The award is presented annually to Judo BC's top judoka, one male and one female. Although competitive results are more heavily weighted in the ranking finalist for the award, the recipient must reflect the principles of Kodokan Judo which emphasize respect for self and opponents, fair play, as well as both mental and physical development.

#### 2. Selection

- a. The Provincial Head Coach will make a recommendation to the Technical Committee within 7 days of the last day of competition at the Canadian Senior National Championship for approval.
- b. The Technical Committee retains the final decision on the annual recipient.
- 3. Presentation:
  - a. The Athlete of the Year will be announced at one of the main tournaments in the fall of each year.

Good morning all,

As you may recall, we discussed during our April 4<sup>th</sup> conference call the definition of probationary member. I have reviewed our current policies and thought it might be prudent to engage everyone in an email dialogue on what changes, if any, need to be made to our policies.

The impetus for this dialogue is recent observations by the board and a few members that being on probation in Judo BC "equates to nothing" other than facilitating the potential future removal of the member IF conditions are tied to the probationary period.

The text below is not a recommendation. It is simply a number of questions and comments to get the discussion started. Your comments/observations will be captured in the form of a recommendation for us to review and present at the AGM in June. The goal is to clearly articulate the disciplinary action linked to being placed on probation vs. suspension.

#### FACT - Current references in our policies concerning probation or probationary status.

- I. Nothing in our constitution and bylaws.
- II. Section 1 Memberships, Item 3 *"The Board of Directors shall review the Membership Committee's recommendation within 30 days of receipt. A Club approved for membership will be placed on a minimum one-year probationary period as determined by the Board of Directors. 3.1 If required, one or more representatives from the Board of Directors, or a designate, may visit the club and head coach to ensure compliance with judo bylaws, policies & procedures and safety practices prior to removing a club from probationary status." Does not affect an individual member.*
- III. Section 3, Finance, Item 8 "Members who are currently suspended or on probation with Judo BC may not be eligible for funding from Judo BC." Could prevent someone from getting AAP funding, funding for nationals, or other out of province activities (i.e.: Ontario Open).

# FACT - Here are the sanctions that can currently be imposed on someone who is <u>suspended</u> (as published in our policies):

- i. written reprimand;
- ii. removal of certain privileges of membership or employment;
- iii. suspension from certain events which may include suspension from the current competition or from future teams or competitions;
- iv. suspension from certain Judo BC activities such as competing, coaching or officiating for a designated period of time;
- v. suspension from employment with or without pay;
- vi. suspension from all Judo BC activities for a designated period of time;
- vii. costs or expenses incurred by Judo BC to send a respondent to a competition or event from which the respondent was dismissed or in which the respondent failed to compete as a result of the alleged infraction;
- viii. expulsion from membership;
- ix. publication of the decision;
- x. other sanctions as may be considered appropriate for the offense.

# QUESTION - Should <u>members</u> who are on probationary status have further restrictions imposed on them?

Working off the premise that a member, not a club, would be placed on probation for disciplinary reasons, should they be allowed ....

- Participate in clinics or competition,
- Represent Judo BC at competition or events,
- Receive any type of support or funding from Judo BC,
- Start a club;
- Lead a club;
- .....

QUESTION – Other than being ineligible for coverage under Judo BC's insurance policy, should a <u>Club</u> on suspension have further action impose on it? What about their members?

# Induction Information

# A THE SELECTION PROCESS:

- Nominations for Induction in the following calendar year are accepted until October 1st.
- Any individual or association may submit a nomination with the following exceptions:
  - A current Member of the BC Sports Hall of Fame Selection Committee may not submit a nomination.
  - A member of the BC Sports Hall of Fame Board of Trustees may submit a nomination but if the Trustee sumits a nomination, that Trustee may not vote on that nomination if and when it is brought to the Board of Trustees for approval.
- Each nomination is eligible for three (3) consecutive years. If at the end of three (3) consecutive years of eligibility, a nomination has not been selected for induction, the nomination must sit inactive for a period of one (1) year after which the nomination can be resubmitted.
- All nominations will be considered at an initial Selection Sub-Committee meeting at the beginning of November. Depending on the outcome of that process, further information on the nomination may be required. The final selection process will take place in the middle of November and the names will be released to the media in December.

# B CATEGORIES: Athlete, Builder, Pioneer, Media and Team

# **SELECTION CRITERIA**

# 1. ATHLETE:

- Any athlete (able bodied or an athlete with a disability) who has attained a high level of excellence and brought recognition or honour to British Columbia sport on a national or international level in relation to participation in open level sport(s) competition.
- A B.C. member of a Canadian Team may stand for induction as an individual athlete.
- An individual is not eligible for nomination until three (3) years following retirement from open level sport(s) competition, except in the event of death or by winning an Olympic or a World championship gold medal whereby the nomination is eligible for immediate consideration.
- An individual retired for a period of three (3) years from open level sport(s) competition, but still competing in Seniors or Masters competition is eligible for consideration.
- Family members (any combination of father, mother, son, daughter, brother, sister, husband, wife, etc) are eligible for induction within the same year. Family members will be considered separately on the basis of their own individual merit. If selected together each will be inducted individually using two (2) or more of the maximum five (5) "Athlete induction spaces" or two (2) of the maximum two (2) "Builder induction spaces." For instance, two brothers selected cannot be inducted as a pair using only one of the five "Athlete induction spaces." This applies to the Pioneer, Media and W.A.C. Bennett Award categories as well.
- A sports organization may not be inducted into the BC Sports Hall of Fame in any category. Individuals representing an organization are permitted for induction.

# 2. BUILDER: (Including, but not limited to, Coach, Referee, Official, and Administrator)

• Attained a high level of excellence and brought honour to British Columbia sport through ongoing dedication to the building of athletes, teams, or sport itself.

# 3. PIONEER: (Individual or Team)

- Attained a high level of excellence and brought honour to British Columbia sport during the period 50 years prior to the current year, while exhibiting a "pioneering" quality in athletic accomplishments.
- Exception to the 50-year clause is made in the case of individuals or teams in more recently developed sports that have some "pioneering" quality to their accomplishments.
- Teams in the Pioneer category are selected for their achievements in one year that best represents a team's accomplishments over a larger era.

# 4. MEDIA:

- Attained a high level of excellence and made a significant contribution to the enjoyment or knowledge of sport in British Columbia through the medium of print, radio, television or any similar form of medium reporting sport nationally or internationally.
- Selection of a media inductee is not required every year. Media inductees will be selected from time to time to recognize individuals who have made an exceptional contribution to sport in BC.

## 5. TEAM:

- Any team (consisting of able bodied or athletes with disabilities) that has attained a high level of excellence and brought recognition or honour to British Columbia sport at a national or international level in relation to open level competition. Team members are recognized as part of a team and not as an individual Honoured Member.
- The BC athletes of a Canadian Team, which has reached special excellence on a national or international level, may be nominated and inducted as a group in the "Team" category.
- Teams are selected for achievements in one year, not an era.
- A team is not eligible for nomination until three (3) years following the year which a team is nominated for except by winning an Olympic or a World championship gold medal whereby the nomination is eligible for immediate consideration. For example, the 1997 Vancouver Canucks would be eligible to be nominated for the 2000 induction class.

# W.A.C. BENNETT AWARD

- This special recognition award is presented from time to time to an individual who has made a significant contribution to sport in British Columbia, but who would not otherwise qualify for induction into the BC Sports Hall of Fame and Museum.
- The candidate must exemplify good character and dedication, and provide inspiration to present and future generations.
